5.3. Advice for firefighters.

GENERAL INFORMATION

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. 6.1. Personal precautions, protective equipment and emergency procedures.

Block the leakage if there is no hazard.

6.3. Methods and material for containment and cleaning up.

RESPIRATORY PROTECTION
